# ADMISSION REQUIREMENTS

Our open-door policy allows students to begin training at any time!

# **ALL APPLICANTS MUST/MUST HAVE:**

- Be at least 16 years of age.
- Have at least completed a 9th grade education
- A high school diploma or a recognized equivalent (GED)
- Recent 2x2 full-faced passport photo
- Copy of the vital statistic birth certificate or valid passport. Hospital certificates are not valid
- Copy of the social security card
- Copy of a valid state issued ID, driver's license or valid passport with intact picture
- Completed and notarized verification of lawful presence attached, if applicable, copy of legal documents that authorize a change in name such as a marriage license, divorce decrees, or other court documents
- Proof of 9th grade completion, high school diploma or GED equivalent
- Negative TB test results. Results can be no longer than 1 year old
- Transcript of any previous certified barbering training



All candidates must have a personal interview with the Director of Admissions prior to admission. The purpose of this interview is to obtain the perspective students overall awareness of the barbering industry.

All candidates must have a tuberculosis test. All ability to benefit candidates are required to take an aptitude test that will be administered by a license test technician. Potential students will not be able to enroll unless they have successfully passed the exam. The cost of the test is \$25 and must be paid prior to testing. All graduates enrolled in the registered barbering and master hair care programs are required to work a minimum of one year in an apprenticeship program prior to self-employment and salon ownership.

## FINANCIAL AID INFORMATION

Tuition and fees include all textbooks, required supplies, and equipment necessary to successfully participate and complete all our programs.

All students are required to pay State Board Exam fees at the completion of the course. Methods of Payment Students must pay the full amount, or monthly payments with Cash, Counter Checks, or Money Orders. After the down payment is paid in full, students can make monthly payments based on the hourly rate of attendance. (Part-time or Full-Time).

# **SELF-PAY OPTION**

PLAN A: This option is paid in full by the scheduled start date and receive a 10% discount on the total cost.

PLAN B-E (12-36 MONTHS): These options are based on the number of months in attendance.

With these options, a \$1200.00 down payment is required with our in house no credit financing! The remaining balance will then, be divided by the number of months that it takes the student to successfully complete the course.
